Women's vision:

- **Gender equality in all spheres of our societies:** education, employment, ownership and control over resources, access to justice, political representation, institutional decision-making, care giving and household and community management. A world where women can fully deploy their potential in all spheres of our societies, meaning without gender-based violence, where women share in land ownership and financial

Women - Priorities for Zero Draft (1)

Food Security – Chapter V - A – § 63

- **Food Sovereignty**
- Strong **binding safeguards** against land grabbing, and resource grabbing from women, local communities and indigenous people's

Women - Priorities for Zero Draft (2)

Green Economy – Chapter III - C – § 43

- Economic indicators and criteria need to **include the informal, precarious and subsistence sectors**
- Beyond GDP – measure **value of women's unpaid labour**

Women - Priorities for Zero Draft (3)

Science and Technology – § 118

- Independent **assessment of new technologies** (e.g. geo-engineering, synthetic biology) and monitoring

Women - Priorities for Zero Draft (4)

Institutional Framework for Sustainable Development

- § 57 We **call** for the establishment of an Ombudsperson or High Commissioner for Future Generations, to promote sustainable development.
- § 51 UNEP specialized agency
- **Add:** Gender parity, Gender strategies, Gender budgeting, Gender Accounting - for new institutions

Women - Priorities for Zero Draft (5)

Gender Paragraph - § 103

- We call for removing barriers that have prevented women from being full participants in the economy **and society** and unlocking their potential as drivers of sustainable development, **including through promotion of gender-responsive sustainable development institutions and policies that advance women's participation and leadership at all levels.** We agree to prioritize measures to promote gender equality in all spheres of our societies, including education, employment, **access to and** ownership of resources, access to justice, political representation, institutional decision-making, care giving and household and community management.

Women - Priorities for Zero Draft (5)

Gender Paragraph - § 104

- We support the work of UN Women, **other intergovernmental agencies working on gender, and women's organizations and networks in civil society** in achieving gender equality and the empowerment of women in all aspects of life and bringing greater attention to the linkages between gender equality **and justice** and the **achievement** of sustainable development.
